	Weekend (WE) Block product consisting of two gas days (Saturday and Sunday), traded from 09:00 on the penultimate working day before the given weekend until 02:59:59 on Saturday (4 hours before delivery starts).	
	Extended Weekend (XWE) Block product traded in cases of public holidays before or after the weekend. The product consists of a minimum of three and a maximum of five consecutive gas days. Trading is from 09:00 on the penultimate working day before the extended weekend until 02:59:59 on the first holiday (4 hours before delivery starts).	
	Saturday (SA) Product with delivery every Saturday, consisting of one gas day. Traded from 09:00 on the penultimate working day before the Saturday until 02:59:59 on the day of delivery (4 hours before delivery starts).	
	Sunday (SU) Product with delivery every Sunday, consisting of one gas day. Traded from 09:00 on the penultimate working day before the Sunday until 02:59:59 on	



the day of delivery (4 hours before delivery starts).	
Individual Holiday (IH) Product for delivery on a gas day that is a public holiday in the Republic of Bulgaria, other than Saturday or Sunday. Traded from 09:00 on the penultimate working day before the holiday until 02:59:59 on the delivery day (4 hours before delivery starts).	

^{*} Working day as defined in this specification refers to a working day in the Republic of Bulgaria. Accordingly, a holiday refers to a non-working day in the Republic of Bulgaria.
